#### **Patrick Logan, JD**

Attorney Patrick Logan has been the Director of Iowa Legal Update and Jail Pro at Police Legal Sciences, Inc. (PLS) since 2022. Before joining PLS, Mr. Logan served as an Assistant Attorney General at the Missouri Attorney General's Office. He managed the Habeas Corpus Unit, which responds to collateral challenges to criminal convictions filed in state and federal court. The Habeas Unit also represents the State and the Department of Corrections in other original writ and declaratory judgment actions. While an Assistant Attorney General, Mr. Logan litigated cases in both state and federal trial-level courts. He also advocated in state and federal appellate courts, including the

United States Court of Appeals for the Eighth Circuit and the United States Supreme Court, and he argued multiple cases of first impression in the Supreme Court of Missouri. In 2017, Mr. Logan was awarded the Missouri Attorney General's "Best Brief" award. Before joining the Missouri Attorney General's Office, Mr. Logan was an Assistant Prosecuting Attorney in Audrain County, Missouri.

Mr. Logan is admitted to practice law in Iowa, Missouri, and New Jersey state courts. He is also admitted in the United States District Court for the Western District of Missouri, the District of New Jersey, the United States Court of Appeals for the Eighth Circuit, and the United States Supreme Court. He graduated from the University of Missouri School of Law, Class of 2015. He also graduated cum laude from the University of Missouri with degrees in History and Sociology.
